Simple Surrogacy’s Fee Schedule and Calendar of Events for Traditional Surrogacy

Step One: The first step to retaining Simple Surrogacy is to schedule a phone or in-office consultation with our Director of Services, Stephanie Scott. During the consult we will address your personal needs and concerns regarding the surrogacy and/or egg donation process. If you have a significant other, they will be required to participate in the consultation. You will be sent an Intended Parent Profile and Program Information. You will need to complete the Intended Parent Profile on your computer and email it back along with a picture of you and your spouse (if applicable). Before acceptance into our program, you will need to pass a state/federal criminal background check. Once you have been accepted into our program and you have chosen to retain Simple Surrogacy to match you with a surrogate mother/egg donor and coordinate the surrogacy/egg donation process, you will need to sign our Agreement for Services and pay the fee for the program you wish to utilize. When we receive your signed Agreement for Services and the program fee, we will begin the matching process and coordinating the Intended Parent(s) medical/psychological screening.

Step Two: Your coordinator will now contact you to begin your medical and psychological screening. We will refer the Intended Father (if applicable) to a doctor who will perform a semen analysis as well as infectious disease screening. The Intended Mother, if using her own eggs, will be referred to a Reproductive Endocrinologist to ensure optimal egg quality and she will too have infectious disease screening performed. Once your medical and psychological screening is complete, we will begin to send you profiles of surrogate mothers based on your specific search criteria. You will review the profile with your spouse (if applicable) and contact Simple Surrogacy with any questions you may have. If you and your spouse decide you would like to pursue a match further with the surrogate, we will then send her your profile for review. The surrogate and her spouse will review your profile and contact us with any questions she may have. If the surrogate decides she would also like to further pursue the match, we will then schedule a conference call for all parties to become better acquainted. After the conference call, if all parties agree to move forward, we will then arrange for you to meet in person. Once you have been successfully matched with a surrogate in our program, your surrogate will begin the medical and psychological screening. This process typically takes about 3 weeks to complete. All medical screening fees will be due directly to the provider utilized for the screening process.

Step Three: Once medical/psychological screening has been completed, you will enter into the Legal Phase. We will help negotiate the contractual terms and fees associated with your agreement to ensure all parties are on the same page before the Agreements are drafted. Legal Fees are paid directly to the attorney you retain. The Legal Phase typically lasts 3 weeks. Once the Agreements have been signed by all parties, our Director of Legal and Escrow, Kristen Hanson, will contact you to arrange for funding of the escrow account. You must initially deposit \$8,000 into the escrow account to cover your surrogates compensation and expenses. All fees due to your surrogate will come out of escrow and the Intended Parent will be sent a monthly itemized statement detailing the escrow activity for that month. If you choose, we can also pay for medical expenses out of the escrow account. When your Surrogate has been confirmed pregnant via ultrasound with a notable heartbeat, you will then fund the escrow account another \$8,000 to cover her next few months of compensation and expenses. It is mandatory to keep a minimum balance of \$5,000 in escrow at all times. Once your surrogate enters the second trimester, you will need to deposit the remainder of the compensation due to her under your legal agreement into the escrow account plus an additional \$5,000 to cover the medical expenses of the labor and delivery. This is non-negotiable. Please understand that it is very important to us to ensure your surrogate receives all of the compensation she is due under your legal agreement, her expenses are paid, and she is not responsible for unpaid medical bills during or after the pregnancy.

INSURANCE

Life Insurance

Purchase of a \$250,000 term policy for Surrogate in case of accidental death.

Approx. \$450/year

Insurance Child(ren)

Intended Parents can secure health insurance coverage for their child or children, if none is readily available, to take effect at birth. They also have the option of paying out-of-pocket for all of their children(s) related health/medical needs.

Note: No child will be covered under a surrogate mothers health insurance policy.

Cost varies based on number of children needing coverage. For international clients can cost up to \$20,000+

Step Four: Once you have an executed Surrogacy Agreement, you are ready to begin the medical process. Your surrogate will be going to the doctor for monitoring of ovulation, follicle count, and the uterine lining. She may be given fertility medications to aid in becoming pregnant. At this time the surrogate will be compensated for starting fertility medications (if required), IUI or Home Insemination Fee, as well as her monthly allowance. Your Surrogate will typically test for pregnancy 12 days post IUI or Home Inseminations. In the event the surrogate is confirmed pregnant via blood test, she will begin to receive her monthly base compensation (10% of her base compensation is paid monthly until delivery).

SURROGATE COMPENSATION/EXPENSES/INCIDENTALS

Traditional Surrogate Base Compensation

Paid to Surrogate in 10 equal installments over the course of the pregnancy, beginning with confirmation of pregnancy via blood test.

Note: In the event the surrogate miscarries before the 32 week of pregnancy, all base compensation payments will cease. If the surrogate mother carries to 32 weeks or more, she will be entitled to all remaining compensation listed in her Surrogacy Agreement.

Inexperienced Carrier: \$20,000-\$25,000

Experienced Carrier: \$25,000 - \$30,000

Monthly Allowance	In lieu of itemized reimbursements, this monthly fee covers in county mileage, childcare for local appointments, telephone calls, postage, co-pays, prenatal vitamins, and pregnancy testing supplies. Note: Begins at contract signing through one month after birth or at termination of Surrogacy Agreement.**	\$150/Monthly
